They have a budget of around \$30 million for this year. Their focus is to prepare young children for school and to keep them and their families safe and secure. Eligible families can get child care help so they can work. Through the Office of Early Learning, funding is available for all VPK children regardless of income. The School Readiness program helps low-income families with child care and child development.

Kara shared her vision for the future. She is very excited about her new team and their enthusiasm and experience. She values the partnership with Alpha Kappa and wants it to continue. She sees a nice increase in outreach and communication within the community. They are planning to begin minimal contact outreach (due to Covid) for the parents by establishing drive-thru offering resources, materials, etc. Some other projects they are working on include: Insights Newsletter, Safe Sleep Kits, Fight for Literacy, Children's Week, and Word of the South. They also celebrated their 20th anniversary on February 28 this year. She did request that we consider using Amazon to donate books, again due to the Covid pandemic. During the Q & A, Lorraine said they would continue outreach with the families by handing out books in the pick-up/drop-off lines at various schools. She also mentioned "Celebrity Read" in which we can participate by reading to children. They also provide a "gift box" for the children and families which includes a book and information for the families. Kara then thanked us all again and said she is very excited about this year and our partnership.
