WOMEN'S PAY BILLS CONTRASTED

Currently there are three pieces of legislation which affect fair pay for women.

- 1. <u>Lilly Ledbetter Fair Pay Act</u> (passed and signed into law in 2008) treats each paycheck which was less that it should have been as a separate instance of pay discrimination. This means that whenever a woman can show that her pay was not commensurate with that of a man in the same job, she is entitled to back pay in the amount of the difference in pay of the two individuals. Thus if the pay discrimination went on for a period of years the woman is entitled to the extra pay (and Social Security difference) for every pay check which represented underpayment.
- 2. <u>Paycheck Fairness Act</u> (H.R.1519, S.797) puts in place the means for women to find out whether a male in the same position is being paid the same amount for the same work. This is important in that you cannot claim pay discrimination if you do not know what a worker in the same job is making. (Lilly Ledbetter would not have known she was being paid less if a fellow worker had not sent her an anonymous note telling her what men in the same position were being paid.)
- 3. Equal Employment Opportunity Restoration Act of 2012 (H.R.5978, S.3317) The bill's purpose is "To restore the effective use of group actions for claims arising under Title VII of the Civil Rights Act of 1964, Title I of the Americans with Disabilities Act of 1990, Title V of the Rehabilitation Act of 1973, section 1977 of the Revised Statutes, and the Genetic Information Nondiscrimination Act of 2008, and for other purposes." Basically in the recent Supreme Court decision involving Betty Dukes and the women workers at Walmart, the court ruled that the women could not file a suit on behalf of the group. Obviously, if each individual has to file separately, this is prohibitively expensive; whereas a group action would cost much less for each person involved.
