# WOMEN IN SPORTS – EXTENDING EQUITY TO HIGH SCHOOLS

During the current financial crisis, schools are dropping some of their sports teams as a cost cutting measure. Sports in which girls participate in high school are much more likely to be discontinued. There is currently legislation pending which could help remedy this situation.

The High School Athletics Accountability Act (H.R. 2882) would require schools which get federal funding to report information on equality in their school athletic programs to the Commissioner for Educational Statistics.

The High School Sports Information Collection Act (S. 471) requires the Commissioner of the National Center for Education Statistics to collect the following information annually from each coeducational secondary school that receives federal funding and that has an athletic program: (1) the number, gender, race, and ethnicity of students that attended the school; and (2) for each team that competed in athletic competition, the number, gender, race, and ethnicity of participants, the total expenditures, the number, gender, employment status, and qualifications of trainers, medical personnel, and coaches, and the number of competitions and practices scheduled.

This type of information has been available for post secondary schools for some time. Sports equity in colleges is enforceable for those schools which receive federal funding. Information obtained as a result of this bill would make participation rates and expenditures for high school athletes at high schools available to the public through the Department of Education web site.

# **BEWARE REQUEST FOR CREDIT CARD INFO**

If you have contact either on-line or by telephone with an entity which asks for your credit card number, BEWARE. The most recent example of this is <u>freecreditreport.com</u>. You are asked for your credit card information before you get your "free credit report." Supplying this information automatically signs you up for a monthly charge and credit report charged to your credit card if you don't cancel within nine days. (The annual charge is \$179.) You can go to **AnnualCreditReport.com**, which is run by the Federal Trade

Commission, and get a truly free report once a year from each of the credit agencies: Equifax, Experian and TransUnion.

Many on-line companies offer a discount on your next order and as part of this "free" discount they request credit card information and sign you up for a "service" which has a monthly fee. The monthly fees typically range from \$9.95 to \$15.99.
