#### INCOME TAX CREDIT

There is a new tax credit called Making Work Pay for people who worked during 2009. The credit for one person earning less than \$95,000 is a maximum of \$400 and for a couple filing jointly both of whom worked is \$800 maximum for couples making less than \$190,000. There are a number of changes which do not take effect until 2014. In this issue I will deal mainly with changes taking place this year. Note that most of these changes do not take effect until September 2010.

## **HEALTH CARE CHANGES**

- 1. Insurers cannot deny coverage for preexisting conditions children (under age 19) cannot be denied coverage for preexisting conditions (effective as of Sept 2010). Adults cannot be denied coverage for preexisting conditions as of 2014,
- 2. Medicare Prescription Drug Donut hole This year Medicare prescription drug coverage is in effect up to \$2700. Seniors who have more than \$2700 in prescription drug expenses will get a \$250 rebate this year. In 2011 those reaching the Donut Hole will pay 50% of the cost of prescription medications when they reach the Donut Hole. (More on this later.) - 3. Children can remain on their parents' medical insurance until they turn 27 years of age effective immediately.
- 4. Caps on coverage There will be no **lifetime** caps on how much health insurance covers (effective 2010), and there will be no **annual** cap on how much health insurance covers (effective 2014)
- 5. There can be no revocation of health insurance based on inaccurate information filled out on the insurance application form. (effective 2010)
- 6. Medicaid can be expanded to include coverage for Family Planning Services. States determine the degree of

expansion.

- 7. Medicaid will cover services from Freestanding birth centers (effective immediately).
- 8. Medicaid will cover a smoking cessation program for pregnant women (effective immediately).
- 9. Abortion can be covered only if it is to save the life of the mother or if the pregnancy is a result of rape or incest. Any other reason for abortion must be paid for from nonfederal government insurance or treated as an out-of-pocket expense.
- 10. Small business employers will receive tax credit to provide health insurance to their employees (effective 2010)
- 11. Women will have direct access to OB/GYN without referral from a primary care physician (effective September 2010)
- 12. High Risk Pools will be established for people who are uninsured and have preexisting conditions. (effective September 2010)

#### NATIONAL LEGISLATIVE SEMINAR

There were 62 attendees at the National Legislative Seminar which was held in Washington, DC from March 14 through March 17.
