Each applicant will be notified by **February 15** as to the status of her selection.

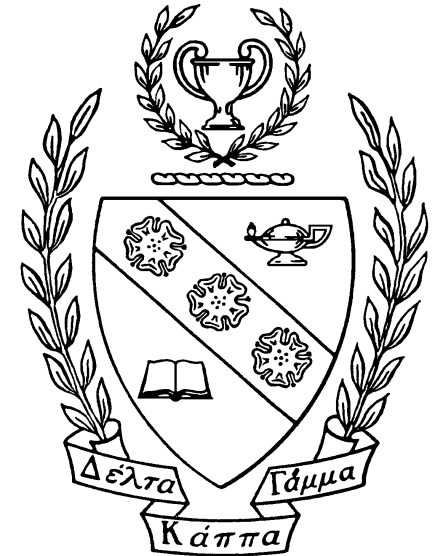
Selected applicants must send written notice of their acceptance to the State Scholarship Chair by **March 1**.

## SCOPE OF THE SPECIAL STUDY STIPEND PROGRAM

In 1997 the Lambda State Scholarship Program was expanded to include Special Study Stipends “to develop skills and meet professional needs” with the wording amended in 2008 to read “to develop skills which promote professional and personal growth.” Special Study Stipends are awarded by Lambda State, not International.

The source of funds is fees, bequests, contributions and income from investments of the Scholarship Fund. Of the \$1.00 scholarship fee paid by Lambda State members, 20% funds International Scholarships; the remainder stays in Lambda State. Contributions are made in memory and honor of the following deceased state presidents.

Lambda State offers stipends to active members based upon the availability of funds in the program. The amount for stipends is recommended to the Executive Board at the state convention. Recipients will be judged on Society participation, recommendations and personal essay.

## ELIGIBILITY REQUIREMENTS

To qualify for a special study stipend the applicant must meet the basic criteria as follows:

- ❖ **Prior to the application deadline, an applicant for a special study stipend shall have completed three (3) years of membership in Lambda State.**
- ❖ **Provide evidence of active participation and leadership in the Society.**
- ❖ **Complete an application form with a reference from the chapter president or immediate past president and a non-DKG professional.**
- ❖ **Application must be e-mailed to the State Scholarship Chair by January 9.**

## TERMS AND CONDITIONS

- ❖ **Special study stipends shall be awarded to develop skills that promote professional and personal growth.**
- ❖ **The educational experience, for which the special study stipends are awarded, shall have been taken between January and December 31 the year preceding the awarding.**
- ❖ **The applicant agrees to remain an active member of The Delta Kappa Gamma Society International.**
- ❖ **The applicant agrees to share information with Delta Kappa Gamma members at a Delta Kappa Gamma function.**
- ❖ **Recipients are encouraged to attend the state convention.**
