

Treasury Notes

Dues, dues, dues... Where does the money go? This question goes through our minds as we write the check verifying our commitment to Delta Kappa Gamma. The simple answer to this question is headquarters, personnel, members, and chapter communities.

DKG headquarters in Austin, Texas, like any property, comes with the responsibility of maintaining the building as well as paying for operating expenses. Since 1956, this 12,500 square foot building has been the center of DKG business, serving the Society, chapters, and members.

Salaries and benefits for 20 staff members who work diligently to serve DKG and its members also come from our dues. The four departments – Operations Services, Membership Services, Membership Services, and Information Services and Executive Services – maintain membership data, pay Society bills, manage the website, reproduce and mail Society publications, answer member questions, process contributions to our various funds, process member dues, ship Society materials, and whatever else needs to be done.

A third portion of our money reimburses members who volunteer to serve as elected officers or on DKG International Boards and Committees. These members plan and provide training to our state organization officers and related personnel in addition to managing the Society's funds, preparing the budget for approval, proposing nominees for International offices, seeking non-dues revenue sources, planning breakout sessions at conferences and conventions and the Golden Gift Leadership/Management Seminar, awarding scholarships, and so much more.

Many member benefits come from our dues and the efforts of the staff and volunteers at DKG Headquarters. Through scholarships, grants, training opportunities, and other DKG funds, money comes back to us and our communities. As I am attempting to put together eight fantastic breakout sessions for the 2016 state conference, I challenge you to create or modify some of your own chapter programs to have that “wow” feature. Programs do not need to be extremely long, but they do need to be ones that the members want to listen to and/or participate in and eventually talk about. If you have trouble thinking about possible programs, you could check out the EEC page on the International website.

Some suggestions for programs:

- Invite some local students to share some of their favorite books.
- Have an anniversary reunion to celebrate 5, 10, 25, or any number of years of membership.
- Invite a law enforcement agent to talk about cyber-bullying.
- Since teaching has changed over the years, have some long-time members tell stories about their early years of teaching.
- Invite a nutrition specialist to explain the needs of the young, the elderly, and the unemployed in your area.

As you're thinking of ways to spruce up your programs, you might think of a small project to go along with the program, such as a collection of popular books to be distributed in shelters or a food drive for the local food bank.

Also, do not forget that these programs might be great ways to get the name of Delta Kappa Gamma out among the public. Take pictures and write a short article that can be submitted to your local newspaper. I will never forget a comment I heard from a lady in one of my liaison chapters: “When I was asked to join Delta Kappa Gamma, I eagerly said, ‘Yes!’ I didn’t know much about the Society, but I always read in the paper about what the DKG women were doing, and I wanted to be a part of it.” Get the word out about your own chapter. You might find it easy to find new members.

International Projects

Are you aware that since the program began in 1960, nearly 1000 women, representing 120 countries, have benefitted from DKG World Fellowship scholarships? Since women's education and training is still not a priority in many areas of the world, it is vital that deserving candidates are able to access higher education in both the U.S. and Canada.

There are currently 20 recipients—6 in Doctoral programs and 13 in Masters programs. In addition, extensions have been granted to four of last year's scholarship recipients. Their areas of study range from Ethnomusicology to Law. Visit the DKG International website, go to the *Committees* header, then *World Fellowship*, and finally the *World Fellowship Recipient Booklet 2015-2016* to learn more information about each. It is interesting to see just how far from home these women have journeyed in order to pursue their educational goals. We can only hope this will create the next generation of international leaders. Unfortunately, there are no recipients currently studying in Indiana.

The number of scholarships granted each year is based on the contributions and bequests received by the fund. As of June, 2014 the total amount contributed was more than \$4,000,000. Anyone, chapters or individuals, can make a tax-deductible gift to the World Fellowship Fund. Use Form 43 or contribute on-line by looking under *Forms, Contribution Forms*. I urge your chapter to make annual contributions to World Fellowship, either as a budgetary item or from donations.


