

# What, Me Lobby?

April 15 was the last lobbying day for ISTA and DKG's special day to work the State House. There's a lot to be learned both about particular legislation and about how the State House functions. For first-timers, the idea of lobbying may seem daunting, so this article offers information that may demystify the work and encourage more members to participate in future legislative sessions.

Lobbying's primary purpose is to meet and communicate, preferrably face-to-face, with legislators, especially the ones who represent you. They need to hear from you directly how various bills, if enacted, will affect teachers, schools, and classrooms full of children, not to mention you personally.

Through lobbying, an ordinary citizen can build a relationship with a legislator. and so become a source of reliable information. Did you know that many legislators depend upon lobbyists to "educate" them about issues? It's true, and you, the professional educator, are trained and experienced in doing that.

A third purpose, however, is for concerned citizens like DKG members to observe and learn how our government, and specifically the legislative branch, actually functions. Courses on government inform but cannot substitute for getting involved. Washington's K Street has given lobbying a dishonorable reputation, but thousands of teachers and other interested citizens, who've done it, know that lobbying is both honest and effective. Your lobbying can be, too. Here's how:

First, let the legislator(s) know you're coming with a phone call or e-mail a day or so before. Mention the bill(s) you're interested in, and even include an invitation to the luncheon ISTA provides on Lobby Days. N.B. the meal is free!

Then, prepare to discuss two or three bills that really matter to teachers, including retired teachers. The briefing ISTA provides on Lobbing Day will provide up-to-the-minute information about a bill's contents, amendments, and status, but using the General Assembly's web site and other sources will provide needed background and detail, too. Besides marshaling reasons and explanations of your legislative position, your preparation could include a real-life example or anecdote that relates to the bill, for some legislators are greatly influenced by such stories.

On Lobbying Day, dress the part. The State House is a place of business; suits and ties for men and appropriate business attire for women mark those people who are "professionals." The casual clothing many teachers wear in the classroom may be accepted by the children, but it subtly trivializes them when among other "professionals," as well as shows a lack of respect for the place and the people who labor there in our behalf.

In the State House, if you find the legislator, speak up. Greet the person, introduce yourself (with the appropriate title), and state where you're from, your relevant professional experience, and why vou're there. Ask whether the legislator has a few minutes right now. Then have a conversation about the bills you mentioned earlier. Ask some questions, too, so that there's mutual exchange of information. Most importantly, ask for the legislator's support on the bill(s) you've been discussing! When leaving, don't forget to thank the legislator for his/her service and time. The next day, an e-mail of thanks and a sentence or two summarizing the conversation is a nice touch.

BUT . . . if the legislator is unavailable, be sure to leave a written message with the receptionist. Include most of the information above, express regret that you couldn't meet, and say that you'll follow up with an e-mail soon. Then, do it.
