# **Telling Your Story**

How will your chapter be remembered in the future? Is there a permanent chapter history detailing each biennium? Does the local organization have an official account of charter members, new members, deceased members, celebrations, outstanding programs, DKG involvement, and community participation?

A history is not to be interpreted as a listing but rather as a story – an overview, one that chronicles details in narrative form at the end of each two-year period. Additionally, minutes, treasurer's reports, and newsletters are a vital art of any chapter history. Chapters with a record of each biennium have a valuable resource available for future use.

If this will be a new project, then accept the challenge. Chapters frequently depend on the current president, volunteers, or a committee to create the history, then opt at a future date to combine copies of several biennia together electronically or in book form to preserve that history permanently.

A new chapter biennium is coming soon. Before it arrives, plan ahead. Begin now to create that important story of current chapter events.

Have you had some difficulty convincing your chapter members that they really CAN be a good president? or treasurer? or secretary? THIS IS THE SECRET TO YOUR NEEDS! Indiana State

DKG offers this training ONLY once a biennium, so this is your only opportunity. Your new president (or treasurer or secretary or committee chair, etc.) will learn she has a support group not only among your chapter but also among other state chapters as well as state leadership.

Training is offered at a "north" site and a "south" site to make the trip a little easier, although you're welcome to attend either location regardless of your geographic location.

The cost is \$30 for each person to attend and includes lunch and handouts. Seven sessions are offered; if your chapter is aiming for the Golden Key Award, you'll need to have members attend at least five of them. As an outgoing president, encouraging the new officers and committee chairmen to attend a CCOT session is one of your last responsibilities. Attendance is not limited to new officers/committee chairs; this can be a way to recruit leadership for future biennia as well. Take advantage of the opportunity to have someone from your chapter attend EACH of the seven sessions.
