## What's a SAP Footprint?

Follow the footprints! Have you reviewed your chapter or state organization SAP with a magnifying glass? When you do, look carefully for the footprints of your committee or office. A. A strategic action plan guides your activities and helps you understand where you've been and where you are going — including specific programs may be less important than including an objective such as "maintain a record of successful chapter programs."
