**SUNDAY:** An exciting part of any convention is the tours of local sites. The 2014 International Convention in Indianapolis was no exception, with shopping, wine tasting, a progressive dinner and a night at the cabaret for DKG members and guests. A special experience caught the eye of **Darlene Cook/Alpha**. It was a day to remember at the Indianapolis Motor Speedway and not just any day! The NASCAR Brickyard 400 was in town! About 30 fans boarded the limo to the track. Time was provided for visiting the speedway museum, shopping for souvenirs, and enjoying a catered lunch in a suite. After three hours, 400 miles, 160 laps and several caution restarts, Jeff Gordon, a hometown favorite, made Brickyard history. ### **Working Together: Building Early Academic Readiness**

Having returned from the International Convention, I'm ready to start a new year as Alpha Rho State President. I look forward to working with you to strengthen the Oregon state organization. Like other states, we continue to lose members and chapters. If we work together, we can turn that around. Our state membership chair, Kelly McIntyre issued a challenge in the last *Trail*. She challenged each chapter to do a **5- to 10-Year Plan** to increase membership. Identify educators who have been working for **5 to 10** years and former members who dropped **5 to 10** years ago. Bring in a member from each category in 2014-2015 to build our Society. There are many reasons educators can't join when asked or members drop out, so let's see if those "reasons" are still with them today after **5 to 10** years.

I attended the International workshop on *Membership Recruiting Strategies* that addressed the **3R's** of membership:

## **DO YOU KNOW YOUR 3R'S?**

### 1. **Retaining Members**

Before seeking new members, we must make sure we know our current members and are meeting their needs. Are you hearing all voices as you engage members in discussions? Are you talking to one another about the value and benefits of membership? Are you celebrating when members have received an award or been honored for something special? All of us like to be honored for our hard work in some way. Are you meeting the needs of your older and younger members so everyone feels she is a valuable part of your chapter? Are you letting members know they are missed if they can't make it to a meeting? Are you offering rides to older members who no longer drive at night or at all? Let's make a special effort this year to support each other!

### 2. **Reinstating Members**

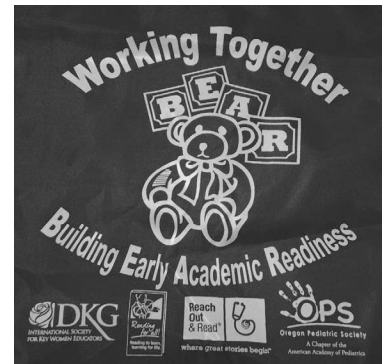
Go back to former members of your chapter and make a personal effort to reconnect with them. Let them know they've been missed. See how they are doing and if circumstances in their lives have changed so they can rejoin. Remember the **5- to 10-Year Plan** above? To find these members, go through old yearbooks or initiation records. Find who invited them to membership. Do they still know how to contact them? Invite former members to a special celebration or to do a program. Hopefully a "no" is not a "no" forever.

### 3. **Recruiting Members**

We can go back to the **5- to 10-Year Plan** again and make a personal contact with women who have been teaching that long and who qualify as "outstanding women educators." If they declined the first invite to join, re-invite them and see if they accept this time. Invite them to a function to see what we're all about. Share

the *DKG Orientation PowerPoint®* available on the International website. Wear your pin when you make these personal contacts to start the conversation. Leave both an International and a chapter brochure so they can contact you and can do some research on DKG.

Yes! Make this the year of the **3R's** of membership and complete the **5 to 10 Year** challenge! I look forward to seeing our list of Red Roses grow! Have a great year! **Kathy**

strengthening, and membership revitalization funds when requested by state organizations.

Attendees were treated to a concert by “Indiana’s Band,” the Wright Brothers, playing western and blue grass. The foot tapping, hand-clapping music had DKG members dancing in the aisles. It was a grand opening to the convention. Monday evening’s ceremony was streamed live via the ‘Net to Society members for the very first time. Did you see it? If you did, let Kathy know how you liked it.

**TUESDAY:** The 2<sup>nd</sup> General Session was called to order on Tuesday morning by International President Dr. Beverly Helms. Twelve hundred DKG members, including six from Alpha Rho State, responded to roll call. Biennium reports of Executive and Administrative Boards were presented by Sandra Bull Smith, Interim Executive Director, and Carolyn Pittman, First Vice President. Dr. Helms’ report as International President provided four suggestions for strengthening the Society and moving us forward: (1) continue strengthening efforts at the chapter level, (2) balance generational differences of members and their involvement in Society leadership roles, (3) continue use of technology and (4) continue use of expansion,

The slate of nominees for the next biennium was presented by the Nomination Committee. Oregon President **Kathy Martell** nominated Past Oregon President **Madaline Lapp** as the Northwest Regional Representative on the Nomination Committee for 2014-2018. Psi Chapter President Kelly McIntyre spoke on strengthening our Society by encouraging chapters to focus on educators with 5 to 10 years’ experience when recruiting members. She emphasized the importance of asking former members to reinstate. Keynote speaker for the session was Ron Roseberg. His presentation, *Double Your Memory*, provided association and storytelling techniques for remembering facts, names and faces.

Tuesday afternoon was reserved for breakout sessions and a Q & A period on the proposed amendment changes to the *Constitution* and *Standing Rules*. Three Alpha Rho State members participated in the breakout sessions. **Kelly McIntyre**, a 2014 graduate of the Golden Gift Leadership Management Seminar, served on a panel with other GGLMS members to *Get in the Fast Track to Leadership*. State President **Kathy Martell**

and Alpha Chapter Immediate Past President **Darlene Cook** presented a breakout session entitled *Alpha Rho State Organization (OR) Reaches Out with BEAR (Building Early Academic Readiness)*. They showed pictures and a video of Mills Elementary students in Klamath Falls “taking the pledge” and celebrating their success in Building Early Academic Readiness with their younger brothers and sisters.

**WEDNESDAY** was a full day. The 3<sup>rd</sup> General Session discussed issues of regional conferences and Society publications. Starting in 2016, hosting a “state night” at regionals will be optional. Registration may now include reduced fees for host state members who are assigned specific duties at the event. Regions will continue to have individual conferences. A new publication will focus on classroom practices, initiatives and viewpoints, reviews of instructional materials, and technology. At the U.S. Forum, **Darlene Cook/Alpha** was introduced as a nominee for the NW Regional Forum Representative and was subsequently voted into this office. Congratulations, Darlene! Birthday Luncheon attendees were entertained by a chime group and had time for visiting and networking.

Oregon’s **Kelly McIntyre/Psi** was presented with a 50<sup>th</sup> Anniversary Project Award from the Educational Foundation to support her counseling project, Lions’ Den. **Judy Brummer/Alpha**, who was unable to attend, also will receive a 50<sup>th</sup> Anniversary Award for her project, *Equipping Students for Scientific Inquiry and Engineering Design*. Congratulations to both ladies!

After lunch, Oregon members had their picture taken and then it was on

**THURSDAY:** Oregon members attended the NW Regional Breakfast. Before the breakfast, **President Kathy** cast Oregon’s 139 votes for the election of our new International officers. **Kelly McIntyre/Psi** was honored by being asked to give the inspirational message! Breakfast was good, company was enjoyable, conversations were lively, and Northwest members donated to the Emergency Fund. Together the regional breakfast groups collected \$20,000 for the Emergency Fund!

After breakfast, the 4<sup>th</sup> General Session was called to order, reports from the five regions were shared, and election results were reported. Angie Ruffin, a North Carolina teacher, sang a delightful song titled *Still Teaching After All These Years!* to the tune of *Glad to Be an American*. She had us all laughing. The business of the *Constitution* and *Standing Rules* filled the time. Upon adjournment, we made our way to breakout sessions again and rehearsals. *Meet & Greet* for the Leadership Management Seminars (Golden Gift), held Thursday afternoon, was attended by **Bridget Honan** and **Madaline Lapp**, 2008; **Kaye Jones**, 2012; and **Darlene Cook** and **Kelly McIntyre**, 2014. “Class” pictures and visiting was fun for all. At the end of the day, Oregon members went *Out on the Town* for dinner and great fellowship.

**FRIDAY:** It’s Friday already? We couldn’t believe the week had gone so quickly! We began the day with a *Celebration of Life* ceremony. Cynthia Morre (Saskatchewan) honored our NW Regional sisters, 21 of whom were from Oregon. The International Choir beautifully sang *Circle of Life* and Jensi Souders (Tennessee) ended the ceremony by playing the *DKG Song* on her flute. In the 5<sup>th</sup> (and final) General Session, we were able to efficiently finish voting on the

**INSTALLATION:** After our meal, new International officers were installed. Nancy Davis (Tennessee) sang *Wind Beneath My Wings* as a thank you from Dr. Helms. The song was beautifully done. Tissues should have been passed out! Next came the passing of the gavel to Dr. Lyn Schmid. Her outstanding acceptance speech is available on the International website (dkg.org) and we strongly urge you to read it. It shows the direction DKG will be headed in the next biennium. Dr. Schmid’s theme for her biennium is **85 Years and Beyond: Advancing Key Women Educators for Life**. Her speech quotes Dr. Annie Webb Blanton as saying, “Be

progressive. Keep up with the moving world while not discarding what in the old has value, but don’t cling to the old when its worth has passed. Don’t be a person so set in your views that nothing can change you.” So expect change in this biennium. If DKG is going to move forward, change must occur. Change needs to start with you. What are you doing to help sustain the Society? What change can you make?

**SATURDAY** we said good-byes. Many hugs were exchanged and promises were given to meet at the next International Convention in Nashville, Tennessee, July 5-9, 2016. We hope more Oregon members will join us there so together we can experience the many inspiring facets of an International Convention.
